Fire Chief's Report (Chief Marcum)

Chief Marcum was not present at the meeting; Chairperson Evan Clapper read the following report:

- Wildland/WUI Fire Danger rating has been elevated to High for South Zone Low Elevation (Under 6000 feet).
- Many Thompson residents have been mowing weeds around their property and helping others who don't have the proper equipment. This work is available for In Kind matching dollars from the State for future fire mitigation projects in the area.
- Thompson Springs Fire Department has been mowing around hydrants to keep them accessible in the event of an emergency.
- Fire Chief is working with County Fire Warden to identify fuels mitigation projects for the future.
- Chief is pursuing confirmation that water use agreement with Crescent Junction UMTRA site is still in effect. This ensures that a helicopter will be able to take water from the Crescent Junction UMTRA site pond in the event of a fire emergency in the vicinity... (Water is safe from any radiation.)

Fire Warden's Report

- Fire Warden Bruce Jenkins gave report. There have been 6 fires caused by humans and 3 fires caused by lightning.
- Made contact with papers to start notifying the public on fire restrictions.
