



Please check the appropriate report being filed:

- June 14 - 21:** Current to within three (3) days of the date of filing, Primary Election Candidates only. Unopposed local school board candidates do not need to file this report.
- July 28:** Final Statements are due from candidates who were eliminated in the Primary Election.
- October 25 - Nov 1:** Reports are due from **all candidates** who will appear on the General Election ballot. This should include all receipts and disbursements from the date of the last report filed to current within three (3) days of the date of this filing.
- January 10, 2023:** Final report filed by **all General Election candidates** or their campaign committee. **The final statements shall include all contributions and disbursements through December 31, 2022.**

Financial reports must be physically received by the elections office no later than 5:00 pm, or received electronically by 12:00 am mountain time on the day of the deadline. Forms can be submitted to janasmith@grandcountyutah.net
